2. Matters arising

- 2.1 <u>Community Facility Marine Harvest Hut:</u> Ongoing: Thanks to all who turned out for a very positive Steering Group meeting. A further meeting is set for Tues 3rd April 7.30pm. Since Duncan contacted Marine Harvest the building has had water damage but this is due to be repaired before any handover.
- 2.2 <u>Hydro Schemes Community Benefit:</u> Ongoing: Dot Ferguson contacted Bob Middleton, TLS Slatach Hydro regarding further Community Benefit. Awaiting update.
- 2.3 Roads issues: Ongoing. A discussion was had about changes to the bridge works at the top of the village. lain Blyth raised some concerns that need to be reworked into the plans.
 - Lower Road: Duncan contacted Pauline Donaldson & Gus about drainage issues and deterioration in the road surface.
 - Tor an Eas: Julia raised some concerns about vision when turning out onto the main road due to signage on one side and overgrown bushes on the other. **Action: Duncan & Alistair to take a look**.
- 2.4 <u>Tourist parking:</u> Ongoing: Duncan contacted Pauline Donaldson, HC. They are not in favour on continuing the white bollards as in their view the parking problem just moves further down the road or to main road. We've requested changing the soft verge signs & adding no parking symbols to the passing place poles.
 - Thanks to Fiona who's filled out an initial application to the HC Tourist Infrastructure Fund. This focuses on parking, pedestrian footpath and speed limit. National Trust Visitor figures were quoted which recorded over 300, 000 official visitors last year. This doesn't cover those not visiting the NT centre. Duncan has contacted Kate Forbes in relation to these issues & Skye's successful funding bid. A meeting is proposed for Sat 21st April. **Action: Duncan to contact Fiona Hyslop, Tourism Minister about the same issues.**
 - Tor an Eas camper van parking problems raised. It is proposed to use some cones to alleviate the issue.
 - Police have asked that any issues be reported (101). If they can't attend it's important that it's still logged.
